THE STATES SEA FISHERIES COMMITTEE, in exercise of the powers conferred upon it by section 1(1) of the Fishing (Licensing and Protection of Fisheries) Ordinance, 1987^a, hereby orders:-

Designated shellfish fisheries

1. The areas of the seashore set out in the Schedule to this Order shall, for the periods specified therein, be designated as Licensed Fisheries in respect of shellfish farming for the purpose of the Ordinance of 1987.

Interpretation

2. (1) In this Order, "**the Ordinance of 1987**" means the Fishing (Licensing and Protection of Fisheries) Ordinance, 1987, and any other expression has the same meaning as in the Ordinance of 1987.

(2) The Interpretation (Guernsey) Law, 1948^b shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

AREAS OF SEASHORE DESIGNATED AS LICENSED FISHERIES
FOR SHELLFISH FARMING

All those parts within the areas enclosed by imaginary lines joining the intersection of the lines of latitude and longitude hereby specified in respect of each such area which are for the purpose of identification delineated on Admiralty Chart 808 published at Taunton on 23rd March 1979, under the superintendence of Rear-Admiral D W Haslam, OBE, Hydrographer of the Navy and which has been endorsed with the words "States of Guernsey – The Fishing (Designation of Shellfish Fisheries) Order, 2001", signed by the President of the Committee on the 14th August 2001 and lodged at the Greffe, namely the following areas:-
