

THE APPOINTMENT OF CONFORMANCE ASSESSMENT INSTITUTIONS IN THE FRAMEWORK OF THE COMPULSORY APPLICATION AND SUPERVI- SION OVER INDONESIA NATIONAL STANDARD (SNI) OF BOTTLED MINERAL WATER (AMDK) (Regulation of the Minister of Industry Number 05/M-IND/PER/2/2013, dated February 11, 2013)

BY GRACE OF GOD THE ALMIGHTY
THE MINISTER OF INDUSTRY OF
THE REPUBLIC OF INDONESIA,

Considering:

- a. in the framework of facilitating the enforcement and supervision over Indonesia National Standard (SNI) of Bottled Mineral Water (AMDK), which is applied compulsorily by Regulation of the Minister of Industry Number 49/M-IND/PER/3/2012, in accordance with the provisions of legislation, the related conformance assessment institutions appointed by Regulation of the Minister of Industry Number 91/M-IND/PER/8/2012 have been evaluated;
- b. in accordance with the result of the evaluation, it's necessary to appoint and stipulate product certification institutes and verification laboratories as contained in the attachment to this regulation as conformance assessment institutions certifying and verifying the quality of bottled mineral water (AMDK);

- c. having regards letters a and b, it is necessary to stipulate a regulation of the Minister of Industry on the appointment of conformance assessment institutions in the framework of the compulsory application and supervision over Indonesia National Standard (SNI) of Bottled Mineral Water (AMDK);

In view of:

Indonesia Number 4020);

4. Government Regulation Number 38 Year 2007 on the sharing of public administration affairs between the government, provincial administration and regency/municipal administration (Statute Book of the Republic of Indonesia Year 2007 Number 82, Supplement to Statute Book of the Republic of Indonesia Number 4737);
5. Presidential Regulation Number 47 Year 2009 on the Establishment and Organization of State Ministries as already amended several times and the latest by Presidential Regulation Number 91 Year 2011;
6. Presidential Regulation Number 24 Year 2010 on Status, Tasks and Functions of State Ministries as well as First-echelon Organizational Structures, Tasks and Functions of State Ministries as already amended several times and the latest by Presidential Regulation Number 92 Year 2011;
7. Presidential Decree Number 78 Year 2001 on the National Accreditation Committee;
8. Presidential Decree Number 84/P Year 2009 on the Establishment of the Second United Indonesia Cabinet for the 2009-2014 period as already amended several times and the latest by Presidential Decree Number 59/P Year 2011;
9. Regulation of the Minister of Industry Number 86/M-IND/PER/9 2009 on Indonesia National Standard in Industrial Sector;
10. Regulation of the Minister of Industry Number 105/M-IND/PER/10/2010 on Organization and

Working Mechanism of the Ministry of Industry;

11. Regulation of the Minister of Industry Number 49/M-IND/PER/3/2012 on Compulsory Application of Indonesia National Standard (SNI) of Bottled Mineral Water;

DECIDES :

To stipulate:

THE REGULATION OF THE MINISTER OF INDUSTRY ON THE APPOINTMENT OF CONFORMANCE ASSESSMENT INSTITUTIONS IN THE FRAMEWORK OF THE COMPULSORY APPLICATION AND SUPERVISION OVER INDONESIA NATIONAL STANDARD (SNI) OF BOTTLED MINERAL WATER (AMDK)

Article 1

To appoint:

- a. The accredited product certification institutes (LSPro) as contained in letter A of Attachment I to this ministerial regulation to conduct the certification of SNI of Bottled Mineral Water (AMDK) compulsorily with the kind mineral water and demineral water;
- b. The accredited verification laboratories as contained in:
 1. letter B of Attachment I to this ministerial regulation to verify bottled mineral water (AMDK) with the kind mineral water and demineral water; and
 2. letter B of Attachment II to this ministerial regulation to verify bottled mineral water

(AMDK) with the kind natural mineral water;

- c. The product certification institutes (LSPro), which have not been accredited as contained in Letter C of Attachment II to this ministerial regulation to certify SNI of Bottled Mineral Water (AMDK) compulsorily with the kind natural mineral water; and
- d. The verification laboratories, which have not been accredited as contained in Letter D of Attachment II to this ministerial regulation to verify bottled mineral water (AMDK) with the kind natural mineral water.

Article 2

- (1) LSPro and Verification Laboratories as meant in Article 1 letters c and d shall comply with requirements as LSPro or Verification Laboratories accredited by the National Accreditation Committee (KAN) in no later than August 29, 2014 and report the accreditation to the Head of the Agency for the Assessment of Industrial Policy, Climate and Quality of the Ministry of Industry.
- (2) In the case of LSPro and/or verification laboratories being not yet accredited in the period as meant in paragraph (1), the appointment of the institutions or laboratories shall be declared expiring.

Article 3

- (1) In the event that the appointment of LSPro as

meant in Article 1 letter c is declared expiring in accordance with the provision as meant in Article 2, the said LSPro shall be obliged to shift the certificate of product using SNI Mark (SPPT-SNI), which has been issued, to LSPro accredited and appointed by a ministerial regulation.

- (2) The Head of the Agency for the Assessment of Industrial Policy, Climate and Quality of the Ministry of Industry shall coordinate the transfer of SPPT-SNI as meant in paragraph (1) in no later than 6 (six) months as from August 29, 2014.
- (3) The transferred SPPT-SNI as meant in paragraph (1) and paragraph (2) shall be declared valid until the said SPPT-SNI expired.

Article 4

- (1) The verification laboratories as meant in Article 1 letters b and d shall be obliged to verify the whole request of LSPro as meant in Article 1 letters a and c and/or technical institutions with equal treatment between LSPro and between technical institutions.
- (2) The obligation to verify as meant in paragraph (1) shall apply to the verification of:
 - a. the issuance of SPPT-SNI of Bottled Mineral Water (AMDK) with the kind mineral water and de-mineral water or natural mineral water;
 - b. the supervision over the compulsory application of SNI of Bottled Mineral Water (AMDK).

Article 5

LSPro and verification laboratories as meant in Article 1 shall report result of certification and verification performance to the Director General of Agro Industry and the Head of the Agency for the Assessment of Industrial Policy, Climate and Quality of the Ministry of Industry.

Article 6

The Head of the Agency for the Assessment of Industrial Policy, Climate and Quality of the Ministry of Industry shall monitor and evaluate the implementation of the provision as meant in Article 2 and Article 4 as well as evaluate performance of the appointed LSPro and verification laboratories as meant in Article 1.

Article 7

- (1) Verification laboratories violating the provision as meant in Article 4 shall have the verification appointment revoked.
- (2) The truth of the violation against the provision as meant in Article 4, shall be judged at a panel meeting of evaluation.

Article 8

Following the promulgation of this ministerial regulation, Regulation of the Minister of Industry Number 91/M-IND/PER/8/2012 on the Appointment

ment of Conformance Assessment Institutions in the framework of the compulsory enforcement and supervision over Indonesia National Standard (SNI) of Bottled Mineral Water (AMDK) shall be revoked and declared null and void.

Article 9

The ministerial regulation shall come into force as from the date of promulgation.

For public cognizance, the ministerial regulation shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
