**THE GRANTING OF AID OF SUPPLIES AND EQUIPMENT  
FOR TRANSMIGRANTS**

THE MINISTER OF TRANSMIGRATION AND SETTLEMENT  
OF FOREST SQUATTERS OF THE REPUBLIC OF INDONESIA,

- Considering :**
- a. that to meet the transmigrants' need for supplies and equipment according to the need on site, it is deemed necessary to review Decree of the Minister of Transmigration and Settlement of Forest Squatters of the Republic of Indonesia No. KEP.64/MEN/1993, particularly on the matters related to the granting of equipment for transmigrants;
  - b. that Decree of the Minister of Transmigration and Settlement of Forest Squatters of the Republic of Indonesia No. KEP.64/MEN/1993 on the granting of aid of supplies and equipment for transmigrants as already amended by Decrees of the Minister of Transmigration and Settlement of Forest Squatters of the Republic of Indonesia Nos. KEP.123/MEN/1994, KEP.55/MEN/1996 and lastly by KEP.93/MEN/1997 particularly on the matters related to the granting of equipment for transmigrants, does no longer agree with the transmigrants' demand and need, and needs to be reviewed;
  - c. that to meet this end it is necessary to stipulate a Ministerial Decree.

- To stipulate       :**    **DECREE OF THE MINISTER OF TRANSMIGRATION AND SETTLEMENT OF FOREST SQUATTERS OF THE REPUBLIC OF INDONESIA ON THE GRANTING OF AID OF SUPPLIES AND EQUIPMENT FOR TRANSMIGRANTS.**
- FIRST               :**    To grant aid of supplies and equipment to the transmigrants in the form of clothing parcels, sleeping equipment, lightings, kitchen utensils, agricultural equipment and trade tools according to type of transmigration and main business patterns developed in accordance with what are stipulated in the Attachment to this Decree.
- SECOND           :**    The granting of aid of supplies and equipment to the transmigrants as meant in the FIRST dictum with respect to their quantity and technical specifications and their interrelatedness with the type of transmigration and main business pattern shall be determined by the Director General for Recruitment and Placement.
- THIRD             :**    with the stipulation of this Decree the provisions on the granting of aid of equipment/supplies as stipulated in Decree of the Minister of Transmigration No. KEP-64/MEN/1993 and its amendments shall be declared annulled and void.
- FOURTHLY       :**    This Decree shall come into force as from the date of stipulation and is subject to rectification in case of error in the future.

| 1.         | Clothing               | : Uniform, work suit, boot shoes, hat and raincoat.  |
| 2.         | Sleeping equipment     | : Mosquito curtain and met.  |
| 3.         | Lighting equipment     | : Lamp and flashlight.   |
| 4.         | Kitchen utensils       | : Rice cooking pot, frying pan + "sotil", kettle, rice container + rice ladle, cup, dish, water dipper, oil jerry can, bucket.   |
| 5.         | Agricultural equipment | : a. tidal rise and fall :<br>mattock, short machete, sickle, hoe, "slundak" and pulling harrow.<br><br>b. non tidal rise and fall :<br>mattock, short machete, sickle, "dandang"/pickax, scraper, pulling harrow and land harrow. |
