THE REGISTRATION AND LICENSING OF PESTICIDE
TECHNICAL SUBSTANCES

THE MINISTER OF AGRICULTURE,

- Considering :**
- a. that the quality of pesticide formulas and the impact of their application are considerably determined by the quality of their technical substances;
 - b. that based on evaluation of applications for the registration of pesticide technical substances already submitted, the relevant substances have fulfilled relevant requirements;
 - c. that based on the above consideration and pursuant to Article 10 of the Decree of the Minister of Agriculture No. 280/Kpts/Um/6/1973, it is deemed necessary to register and grant licences to the pesticide technical substances as meant in point b.

HAS DECIDED :

**To stipulate : DECREE OF THE MINISTER OF AGRICULTURE CONCERNING THE
REGISTRATION AND LICENSING OF PESTICIDE TECHNICAL
SUBSTANCES.**

Article 1

- (1) Pesticides technical substances which are contained in column 2 of the attachment to this decree shall be registered and granted fixed licences pursuant to Article 7 of the Decree of the Minister of Agriculture No. 280/Kpts/Um/6/1973, in the names of registration holders as contained in column 6 with registration numbers as contained in column 7 of the said attachment.
- (2) Fixed licences shall be effective for 5 (five) years starting from the date of stipulation of this decree.
- (3) Registration holders as meant in paragraph (1) shall be allowed to distribute, and the disseminate information on, the pesticide technical substances as meant in paragraph (1) in line with the provisions and acts force.
- (4) The status of registration holders as meant in paragraph (1) shall be subject to review if they are no longer appointed to register the relevant pesticide technical substances or fail to comply with the provisions and acts in force.
- (5) Applications for registration of the technical substances as meant in paragraph (1) shall be filled not later than 3 (three) months before the expiration of the licences as meant in paragraph (2).

Article 2

The pesticide technical substances as meant in Article 1 paragraph (1) shall contain active substances as indicated in column 3, minimum grades of active substances as listed in column 4 and forms as shown in column 5 of the said attachment.

Article 3

The pesticide technical substances as meant in Article 1 paragraph (1) shall only be stored and distributed in original containers, packages and labels pursuant to the Decree of the Minister of Agriculture No. 429/Kpts/Um/9/1973 and other relevant provisions in force.

Article 4

The technical substances as meant in Article 1 paragraph (1) shall only be used for the production of pesticide formulas which have been registered.

Article 5

- (1) The registration holders as meant in Article 1 paragraph (1) shall guarantee that the pesticide technical substances they register fulfil requirements for quality, containers, packages and labels as stipulated in Article 2 and Article 3 and comply with other provisions as referred to in their registration documents.
- (2) The registration holders as meant in Article (1) paragraph (1) shall only be allowed to distribute their registered pesticide technical substances to registration holders of pesticide formulas using the same active substances as those of the pesticide technical substances already registered.
- (3) The registration holders as meant in Article 1 paragraph (1) shall submit reports to the Pesticide Commission on every delivery of the registered technical substances to formula registration holders, not later than 1 (one) month after delivery.

Article 6

The licences as meant in Article 1 paragraph (1) shall be subject to amendment, replacement or revocation in the case of the pesticide technical substances as meant in Article (1) failing to comply with relevant provisions and laws in force, producing undesired side effects, or being found out to have the potential for certain hazards previously unknown.

Article 7

This decree shall come into force as from the date of stipulation.
