**COMPULSORY REGISTRATION OF LUBRICATING OIL CIRCULATING
IN INDONESIA**

THE MINISTER OF MINES AND ENERGY,

- Considering :**
- a. that in line with the Decree of the Minister of Mines and Energy No. 45K/34/MPE/1999 dated February 4, 1999 the period for circulation and or marketing of lubricating oil which does not have the Registration Number is up to December 31, 1999;
 - b. that based on the matter as referred to in letter a above, in the context of maintaining the sound business climate in the supply and service of lubricating oil in Indonesia and constantly guaranteeing consumers to obtain quality lubricating oil, it is necessary to make efforts and to take steps which relate to the compulsory registration of lubricating oil circulating in Indonesia in a Decree of the Minister of Mines and Energy;

H A S D E C I D E D :

To Stipulate :

- FIRSTLY :** The applications for registration of lubricating oil which were submitted before January 1, 2000 and met technical and administrative requirements can be provided with the Provisional Registration Number (NPS) and can continue to be distributed and or be marketed up to September 30, 2000.
- SECONDLY :** Companies which up to December 31, 1999 had not submitted the applications for the registration number (NPT), the lubricating oil which has been distributed and or marketed shall immediately be withdrawn from circulation and or markets.
- THIRDLY :** With the effect as from October 1, 2000 :
- a. Any type of lubricating oil which is distributed and or marketed in Indonesia shall have and or mention the Registration Number;
 - b. Lubricating oil having no registration number and or does not mention the registration number cannot be distributed and or marketed and shall be withdrawn from circulation and or markets.
- FOURTHLY :** The Director General of Oil and Gas further stipulates the implementation rule of this Decree of the Minister.
- FIFTHLY :** With the enactment of this Decree of the Minister, the Decree of the Minister of Mines and Energy No. 45 K/34/MPE/1999 is declared void.
- SIXTHLY :** This Decree of the Minister shall come into force as from the date of stipulation.
