

PROCEDURES FOR SHARING RESULTS OF REVENUE FROM LAND AND BUILDING TITLE ACQUISITION FEE BETWEEN THE CENTRAL AND REGIONAL GOVERNMENTS
(Regulation of the Minister of Finance No. 32/PMK.03/2005 dated May 23,2005)

THE MINISTER OF FINANCE,

Considering:

That in the framework of implementing the provision in Article 23 paragraph (3) of Law No. 21/1997 on land and building title acquisition fee as already amended by Law No. 20/2000, it is necessary to stipulate a regulation of the Minister of Finance on procedures for sharing results of revenue from land and building title acquisition fee between the central and regional governments;

In view of:

1. Law No. 21/1997 (BN No. 6106 pages 16A - 20A and so on) on land and building title acquisition fee (Statute Book of 1997 No. 44, Supplement to Statute Book No. 3688) as already amended by Law No. 20/2000 (BN No. 6562 pages 13A - 20A and so on) (Statute Book of 2000 No. 130, Supplement to Statute Book No. 3988);
2. Law No. 18/2001 (BN No. 6718 pages 18A - 21A and so on) on special autonomy for the Province of Aceh Special Region as the Province of Nanggroe Aceh Darussalam (Statute Book of 2001 No. 14, Supplement to Statute Book No. 4134);
3. Law No. 33/2004 (BN No. 7206 pages 1A - 6A and so on) on financial sharing between the central government and regional administration (Statute Book of 2004 No. 126, Supplement to Statute Book No. 4438);
4. Presidential Decree No. 42/2002 (BN No. 6802 page 32A and so on) on the realization of the State Budget of Revenue and Expenditure (Statute Book of 2002 No. 73, Supplement to Statute Book No. 4214) as already amended by Presidential Decree No. 72/2004 (BN No. 7123 pages 2A - 4A) (Statute Book of 2004 No. 92, Supplement to Statute Book No. 4418);
5. Presidential Decree No. 187/M/2004 (BN No. 7128 pages 30A - 31A);
6. Qanun (Regional Regulation) of the Province of

Nanggroe Aceh Darussalam No. 4/2002 on financial sharing between the provincial and regental/municipal governments;

7. Decree of the Minister of Finance No. 254/KMK.01/2004 on the organization and working arrangement of Jakarta Regional Office I of the Directorate General of Taxation, Medium-level Tax Service Office and Primary Tax Service Offices within the Jakarta Regional Office I of the Directorate General of Taxation;
8. Regulation of the Minister of Finance No. 606/PMK.06/2004 on guidelines on the payment in the realization of the State Budget of Revenue and Expenditure 2005;

D E C I D E S :

To stipulate:

THE REGULATION OF THE MINISTER OF FINANCE ON PROCEDURES FOR SHARING RESULTS OF REVENUE FROM LAND AND BUILDING TITLE ACQUISITION FEE BETWEEN THE CENTRAL AND REGIONAL GOVERNMENTS.

Article 1

Results of revenue from land and building title acquisition fee constitute state revenue.

Article 2

- (1) Results of revenue from land and building title acquisition fee are shared by the central and regional governments with the ratio as follows:
 - a. 20% (twenty percent) to the central government;
 - b. 80% (eighty percent) to region.
- (2) The right of the central government as high as 20% (twenty percent) as meant in Article 2 paragraph (1) letter a is shared in the same portion to all regencies/cities.
- (3) The right of the region as high as 80% (eighty percent) as meant in Article 2 paragraph (1) letter b is specified as follows:

- a. 16% (sixteen percent) to the said province and channeled through the Regional General Cash of the province;
- b. 64% (sixty four percent) to producing regencies/cities and channeled through regional general cash of the regencies/cities.

(4) Especially for the Province of Nanggroe Aceh Darussalam, the right of the region as high as 80% (eighty percent) as meant in paragraph (1) letter b is specified as follows:

- a. 16% (sixteen percent) to the provincial region, which is shared with the proportion as follows:
 - 1) 30% (thirty percent) to the educational fund in the Province of Nanggroe Aceh Darussalam and channeled through the special account of educational fund;
 - 2) 70% (seventy percent) to the provincial region and channeled through the provincial cash.
- b. 64% (sixty four percent) to producing regencies/cities, which is shared with the proportion as follows:
 - 1) 30% (thirty percent) to educational fund in the Province of Nanggroe Aceh Darussalam and channeled through the special account of educational fund;
 - 2) 70% (seventy percent) to the producing regencies/cities and channeled through the regional cash of regencies/cities.

Article 3

(1) At the end of every month, Heads of local Land and Building Tax Service Offices/Primary Tax Service Offices on behalf of the Minister of Finance issue Decision on Stipulation of the Sharing of Results of Revenue from Land and Building Title Acquisition Fee (KP-PHP-BPHTB).

(2) Based on KP-PHP-BPHTB as meant in paragraph (1), Heads of local Land and Building Tax Service Offices/Primary Tax Service Offices on behalf of the Minister of Finance issue Order to Pay the Sharing of Results of Revenue from Land and Building Title Acquisition Fee (SPM-PHP-BPHTB) to the respective provinces and regencies/cities.

Article 4

Models of KP-PHP-BPHTB and SPM-PHP-BPHTB are as stipulated in Attachments I and II to this regulation.

Article 5

Especially for the Province of Nanggroe Aceh Darussalam, Models of KP-PHP-BPHTB and SPM-PHP-BPHTB are as stipulated in Attachments III and IV to this regulation.

Article 6

Results of the revenue as meant in Article 2 paragraphs (2) and (3) constitute regional income and mentioned in Regional Budgets of Revenue and Expenditure in every fiscal year.

Article 7

Further technical provisions on the sharing of results of revenue from land and building title acquisition fee being the right of the central government to regencies/cities as meant in Article 2 paragraph (2) are further regulated by a joint regulation of the Director General of Treasury and Director General of Taxation.

Article 8

With the enforcement of this regulation:

1. Decree of the Minister of Finance No. 519/KMK.04/2000 on procedures for sharing results of revenue from land and building title acquisition fee between the central and regional governments as already amended by Decree of the Minister of Finance No. 550/KMK.03/2002 is revoked and declared null and void.
2. Technical regulations already existing in the field of procedures for sharing results of revenue from land and building title acquisition fee between the central and regional governments remain effective as long as they do not contravene this regulation.

Article 9

The regulation comes into force as from the date of stipulation.

For public cognizance, the regulation shall be announced by placing it in State Gazette of the Republic of Indonesia.
