REGISTRATION OF PESTICIDES FOR EXPORT
(Decree of the Minister of Agriculture and Forestry No. 507/Kpts/TP.270/10/2000
dated October 27, 2000)

THE MINISTER OF AGRICULTURE AND INDUSTRY,

Considering:

- a. that several countries express their interests in importing pesticides registered in Indonesia with certain requirements;
- b. that applications for the registration of pesticides proposed have been evaluated and considered fulfilling the requirements set for pesticide especially exported ones;
- c. that based on the above mentioned matters, it is necessary to register pesticides for export;

In view of:

Observing:

The Opinion of the Pesticide Commission in its letter No. 417/Kompes/2000 dated September 18, 2000;

DECIDES:

To stipulate :

THE DECREE OF THE MINISTER OF AGRICULTURE AND FORESTRY ON THE REGISTRATION OF PESTICIDES FOR EXPORT.

Article 1

- (1) The pesticides as mentioned in column 2, registered with the numbers of registration as described in column 5, on the names of the registration holders as described in column 4 of this decree are used only for export purposes and are not allowed to be distributed and used in the country.
- (2) The pesticides as meant in sub-article (1) in accordance with data and information provided in the application for registration contain active materials and have formulas as described in columns 2 and 3 of the attachment to this decree.

Article 2

- (1) The registration as meant in Article 1 is effective for the period of 5 (five) years and extendible.
- (2) The re-registration of pesticide as meant in Article 1 must be submitted in writing before the end of the effectiveness of the license as meant in sub-article (1).

Article 3

The holders of the registration as meant in Article 1, sub-article (1) are obliged to:

- a. guarantee the quality of pesticide in accordance with data and information as provided in the application for registration;
- b. guarantee the place, packing and labeling of pesticide in accordance with Decree of the Minister of Agriculture No. 429/Kpts/Um/9/1973 and/or the other existing provisions;
- c. submit annual reports on the realization of the export of his pesticide to the Minister of Agriculture through the Pesticide Commission.

Article 4

For certain purposes, based on the request from importers, the Minister of Agriculture can consider the change in the name, place, and labeling of the pesticide as meant in Article 1, sub-article (1).

Article 5

The registration as meant in Article 1, sub-article (1) can be revoked if:

- a. the mentioned pesticides are not relevant with data and information in the application for registration;
- b. the mentioned pesticides are found potential to endanger the health of the people and the environment which are not known previously;
- c. the mentioned pesticides are distributed and/or used domestically and/or violations against the existing regulation are occurred.
- d. the holders of the registration do not submit reports on the realization of export of pesticides for the period of 2 (two) consecutive years.

Article 6

This decree starts to be effective as from the date of stipulation.
