

## NATIONAL DEVELOPMENT POLICY AND STRATEGY OF DRINKING-WATER SUPPLY SYSTEM (KNSP-SPAM)

(Regulation of the Minister of Public Works No. 20/PRT/M/2006 dated September 15, 2006)

THE MINISTER OF PUBLIC WORKS,

Considering:

- a. that drinking water constitutes basic need badly needed for sustainable human life in the framework of enhancing the health quality of the people;
- b. that in order to meet the basic need, a drinking-water supply system having good quality, being healthy, efficient and effective, integrated with other sectors, mainly the sanitation sector is needed so that the people can live healthily and productively;
- c. that in the framework of enhancing service/supply of drinking water, it is necessary to develop drinking-water supply system with a view of building, expanding and/or enhancing the physical (technical) system and non-physical systems (institution, management, finance, public participation and law) totally to realize the provision of drinking-water for communities towards a better and prosperous condition;
- d. that in a bid to realize the expected drinking-water supply system as meant in letters a, b and c, integrated, efficient and effective plans, programs and implementation of activities are needed;
- e. that in order to realize the expected situation and condition as meant in letter d, national development policy and strategy of drinking-water supply system needs to be stipulated by a regulation of the Minister of Public Works;

1. The Need for National Development Policy and Strategy of Drinking-Water Supply System as a guidance for providing drinking-water as mandated by Government Regulation No. 16/2004;

Declarations of the United Nations Meetings, particularly Habitat Declaration and Agenda 21 in Rio de Janeiro on Adequate Shelter for Human and Sustainable Resettlement Development which needs to be realized in national policy and strategy of drinking-water supply system development, particularly in the provision of access to better service for the poor;
3. UN Millenium Summit in September 2000, resulting in Millenium Development Goals (MDGs) in the framework of realizing a better living environment;

**THE REGULATION OF THE MINISTER OF PUBLIC WORKS  
ON NATIONAL DEVELOPMENT POLICY AND STRATEGY  
OF DRINKING-WATER SUPPLY SYSTEM**

**Article 1**

Referred to in this regulation as:

1. National Development Policy and Strategy of Drinking-Water Supply System, hereinafter abbreviated to KSNP-SPAM constitutes guidelines on regulation, implementation and development of drinking-water supply system for the central and regional governments, business communities, private and society.
2. KSNP-SPAM covers descriptons of visions and missions of drinking-water supply system development, strategic issues, problems and challenges of SPAM development, goals/targets as well as national policies and strategies of SPAM development and the required action plans.

**Article 2**

KSNP-SPAM is used as guidance for regulating, implementing and developing good- quality drinking-wa-

ter supply system in the central and regional levels in accordance with conditions of local regions.

**Article 3**

More detailed technical regulations and operational guidelines in the regulation, implementation and development of drinking-water supply system as elaboration of KSNP-SPAM need to be formulated and stipulated further by the institutions concerned.

**Article 4**

- (1) In the case of regions not yet having the regulation as meant in Article 2, provisions and plans for drinking-water supply system development in the regions need to be prepared and stipulated by regional regulation, referring to this ministerial regulation.
- (2) In the case of regions already having regional regulation on drinking-water supply system development before the issuance of this regulation, the regional regulation should be adjusted on the basis of the provisions as meant in this regulation.

**Article 5**

With the enforcement of this regulation, regulation, formulation of plans, programs and implementation of development activities of drinking-water supply system must refer to this regulation.

**Article 6**

- (1) The regulation comes into force as from the date of stipulation and it shall be amended and rectified accordingly in the case of mistake being found.
- (2) The regulation is disseminated to the parties for information and proper implementation.
