(Regulation of the State Minister for Environmental Affairs Number 08 of 2006 dated August 30, 2006)

Considering:

- a. that to implement the provision of Article 14 paragraph (2) and Article 17 paragraph (2) of Government Regulation Number 27 of 1999 regarding Environmental Impact Analysis, Decree of State Minister No. KEP-14/MENLH/3/1994 regarding General Guidance for the Preparation of Environmental Impact Analysis and Decision of the Head of the Environment Impact Control Body Number 9 of 2000 regarding Guidance for Preparation of Environmental Impact Analysis were already stipulated.
- b. that Decree of the State Minister for Environmental Affairs Number KEP-14/MENLH/3/1994 regarding General Guidance for Preparation of Environmental Impact Analysis and Decision of the Head of Environment Impact Control Body Number 9 of 2000 regarding Guidance for Preparation of Environmental Impact Analysis are no longer suitable to the progress thereby requiring renewal;
- c. that based on the consideration as referred to in letters a and b, it is necessary to stipulate a Regulation of the State Minister for Environmental Affairs regarding Guidance for the Preparation of Environmental Impact Analysis;

D E C I D E S :

To Stipulate:

THE REGULATION OF THE STATE MINISTER FOR ENVIRONMENTAL AFFAIRS REGARDING GUIDANCE FOR THE PREPARATION OF ENVIRONMENTAL IMPACT ANALYSIS.

Article 1

The scope of this Regulation of Minister shall comprise Guidance on Preparation of Terms of Reference on Environment Impact Analysis, Guidance on Preparation of Environment Impact Analysis, Guidance on Preparation of Environment Management Plan, Guidance on Preparation of Environment Monitoring Plan and Guidance of Preparation of Executive Summary.

Article 2

- (1) Terms of Reference of Environment Impact Analysis shall be prepared on the basis of Guidance for the Preparation of Terms of Reference of Environmental Impact Analysis as contained in Appendix I to this Regulation of Minister.
- (2) Environment Impact Analysis shall be prepared on the basis of Guidance for Preparation of Environmental Impact Analysis as contained in Appendix II to this Regulation of Minister.
- (3) Environment Management Plan shall be prepared on the basis of Guidance for the Preparation of Environment Management Plan as contained in Appendix III to this Regulation of Minister.
- (4) Environment Monitoring Plan shall be prepared on the basis of Guidance for Preparation of Environment Monitoring Plan as contained in Appendix IV to this Regulation of Minister.
- (5) Executive Summary shall be prepared on the basis of Guidance for Preparation of Executive Summary as contained in Appendix V to this Regulation of Minister.
- (6) The appendices as referred to in paragraphs (1), (2), (3), (4) and (5) shall be an integral part of this Regulation of Minister.

Article 3

Document of Environmental Impact Analysis being the in process and/or already submitted prior to the stipulation of this Regulation of Minister shall refer to the previous Guidance for the Preparation of Environmental Impact Analysis.

Article 4

By the enforcement of this Regulation:

- a. Decree of the State Minister for Environmental Affairs Number KEP-14/MENLEH/3/1994 regarding General Guidance for the Preparation of Environmental Impact Analysis shall be revoked and declared null and void.
- b. Decision of the Head of the Environment Impact Control Body Number 9 of 2000 regarding Guidance for the Preparation of Environmental Impact Analysis shall be revoked and declared null and void.

Article 5

This Regulation of Minister shall become effective as of the date of stipulation.
