European Communities (Avian Influenza) (Control on Imports from Croatia)(Amendment) Regulations (No. 2) 2006

I, Mary Coughlan, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), and for the purpose of giving effect to Commission Decision 2006/256/EC¹ of 27 March 2006, hereby make the following regulations:-

1. These Regulations may be cited as the European Communities (Avian Influenza) (Control on Imports from Croatia)(Amendment) Regulations (No. 2) 2006.
2. The European Communities (Avian Influenza) (Control on Imports from Croatia) Regulations 2005 (S.I No. 691 of 2005) are amended by -

- (a) the substitution, for the definition of “Commission Decision” in regulation 2(1), of -

" 'Commission Decision' means Commission Decision 2005/758/EC² as amended by Commission Decision 2006/11/EC³ and Commission Decision 2006/256/EC' ";

- (b) the substitution, for the definition of “Croatia” in regulation 2(1), of -

" 'Croatia' means part of the territory of Croatia as described in the Annex to Commission Decision 2005/758/EC as amended by Commission Decision 2006/256/EC' ";
