**European Communities (Avian Influenza) (Control on Imports of Avian Products from Romania) (Amendment) Regulations 2006**

I, Mary Coughlan, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), and for the purpose of giving effect to Commission Decision 2006/396/EC<sup>1</sup> of 2 June 2006, hereby make the following regulations:-

1. These Regulations may be cited as the European Communities (Avian Influenza) (Control on Imports of Avian Products from Romania) (Amendment) Regulations 2006.
2. The European Communities (Avian Influenza) (Control on Imports of Avian Products from Romania) Regulations 2006 (S.I. No. 71 of 2006) are amended by -

- (a) the substitution, for the definition of "Commission Decision" in regulation 2(1), of -

" 'Commission Decision' means Commission Decision 2005/710/EC<sup>2</sup> as amended by Commission Decision 2006/23/EC<sup>3</sup> of 20 January 2006, Commission Decision 2006/24/EC<sup>4</sup> of 20 January 2006, Commission Decision 2006 2006/321/EC<sup>5</sup> of 28 April 2006 and 2006/396/EC of 2 June 2006' ";
