I, Mary Coughlan, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972) for the purpose of giving effect to Commission Directive No. 2005/86/EC of 5 December 2005¹, Commission Directive No. 2005/87/EC of 5 December 2005² and Commission Directive 2006/13/EC of 3 February 2006³, hereby make the following regulations—

1. (1) These Regulations may be cited as the European Communities (Undesirable Substances in Feedingstuffs) (Amendment) Regulations 2006.

2. In these Regulations “Principal Regulations” means the European Communities (Undesirable Substances in Feedingstuffs) Regulations 2003 (S.I. No. 317 of 2003).

3. Regulation 2(1) of the Principal Regulations is amended by substituting for the definition of “Directive” the following:

“‘Directive’ means Directive No. 2002/32/EC of the European Parliament and of the Council of 7 May 2002⁴ as amended by Commission Directive No. 2003/57/EC of 17 June 2003⁵; Commission Directive No. 2003/100/EC of 31 October 2003⁶; Commission Directive 2005/8/EC of 27 January 2005⁷; (from 26 December 2006) Commission Directive 2005/86/EC of 5 December 2005; (from 26 December 2006) Commission Directive 2005/87/EC of 5 December 2005 and Commission Directive 2006/13/EC of 3 February 2006.”.
