FOOT-AND-MOUTH DISEASE (SERA AND GLANDULAR PRODUCTS) (JERSEY) ORDER 1958¹

THE ECONOMIC DEVELOPMENT COMMITTEE, in pursuance of Articles 3 and 42 of the Diseases of Animals (Jersey) Law 1956,² orders as follows –

Commencement [[see endnotes](#)]

1 Regulation of the use of sera and other substances

- (1) No person shall treat any cattle, sheep, goats or other ruminating animals, or any swine, with any glandular extract or serum, unless the substance was sold or supplied to the person in a vessel, container or package bearing a label containing the following words, namely –

“The use of this preparation for veterinary purposes is authorized under the Foot-and-Mouth Disease (Sera and Glandular Products) (Jersey) Order 1958”.
- (2) No such label shall be applied to any vessel, container or package containing any such substance as aforesaid except by a person for the time being authorized by the Minister to do so or otherwise than in accordance with such conditions as the Minister may from time to time determine.
- (3) The Minister may at any time withdraw any authorization granted as aforesaid.
- (4) Nothing in this Article shall be deemed to prohibit the use of any substance sold or supplied in a vessel, container or package bearing a label prescribed by the Foot-and-Mouth Disease (Sera and Glandular Products) Order of 1939 (of Great Britain) as amended by any other Order, or by any Order revoking and re-enacting that Order with or without further amendment.

2 Offences

Any person aiding, abetting, counselling or procuring the commission of any breach of the provisions of this Order or of any conditions or requirements of any authority granted under this Order shall be guilty of an offence against this Order.

3 Saving

Any authorization granted under the Foot-and-Mouth Disease (Sera and Glandular Products) (Jersey) Order 1956,³ and subsisting immediately before the coming into force of this Order shall continue to have effect as though granted under this Order.

4 Citation

This Order may be cited as the Foot-and-Mouth Disease (Sera and Glandular Products) (Jersey) Order 1958.
