NOTIFICATION

Whereas it is expedient to make, amendments and additions in the Northern Areas Fisheries Rule 197

Now, therefore, the Provincial Government for Northern Areas is pleased to make the following amendments, substitutions and additions in the Northern Areas Fisheries Rules, 197, which shall come into force at once:-

**Section 4(1)
Destruction of Fish by explosive**

In the existing proviso of rule 4(1) of the aforesaid rules after the words “closed season “the words” for local fish “ shall be inserted and the following new proviso shall be added.

“Provided further that the period from 10th October to 9th March each year shall be closed season during which no fishing of trout shall be permissible. Similarly from 1st to 15th May each year shall be closed season during which no fishing of carp shall be permissible.

**Section 7
Fees for the licences**

For rule-7 of the aforesaid rule, the following shall be substituted and section 19 of the rules shall be construed to have been deleted.

7. The Fees for licences specified in rule-4 shall be as follows:-

SECOND SCHEDULE**(SECTION NO.21)**

S.No.	Description of offences	Maximum amount which may be accepted as compensation
1.	Fishing with net having a smaller mesh than the prescribed mesh	Five hundred only
2.	Fishing without licence	-do-
3.	Killing fish of size less than the prescribed size	-do-
4.	Fishing with any gear or method other than permitted under rules.	-do-
5.	Using at any one time more than two of either or any of the gears permitted under rules.	-do-
6.	License holder employing or engaging non license holder to help him with his nets while fishing.	-do-
7.	Offering or exposing for sale or barter of any fish in contravention of the provision of this act.	-do-
8.	Killing of fish with the use of explosives, poison, lime, noxious material, liquid, Petroleum gas or electricity.	Ten thousand only
