Soil Conservation Regulation 1998

[as amended by all amendments that commenced on or before 24 March 2000]

1 Short title

This regulation may be cited as the *Soil Conservation Regulation 1998*.

2 Existing approved project plans continue in force

- (1) The approval of the Governor in Council under section 15 of the Act of each approved project plan mentioned in the schedule, column 1 continues in force.
- (2) The project area for each approved project plan continues to be constituted for the area.

Editor's note—

Each project area has the same name as the name of the approved project plan for the project area.

3 Approved project plans must be available for inspection

The chief executive must keep a copy of each approved project plan available for inspection by anyone, during normal office hours—

- (a) at the department's head office; and
- (b) at the department's regional office mentioned in the schedule, column 2 for the plan.
