## **Local Government (Aboriginal Lands) Regulation 2001**

[as amended by all amendments that commenced on or before 30 October 2006]

### **1 Short title**

This regulation may be cited as the *Local Government (Aboriginal Lands) Regulation 2001*.

### **2 Reservation of parts of Shire of Aurukun—Act, s 6(3)**

- (1) The land within the Shire of Aurukun, mentioned in schedule 1, column 1,<sup>1</sup> is reserved and set apart as a reserve for the purposes stated opposite in column 2.
- (2) The person mentioned opposite the land in column 3 is appointed as trustee for the reserve.

### **3 Reservation of parts of Shire of Mornington—Act, s 6(3)**

- (1) The land within the Shire of Mornington, mentioned in schedule 2, column 1, is reserved and set apart as a reserve for the purposes stated opposite in column 2.
- (2) The person mentioned opposite the land in column 3 is appointed as trustee for the reserve.
