ORDER OF THE MINISTRY OF NATURAL RESOURCES OF THE RUSSIAN FEDERATION NO. 226 OF OCTOBER 14, 1998 ON DIVISION OF POWERS BY OBJECTS OF LICENSING

In order to streamline the process of licensing the use of water areas of internal sea waters and the territorial sea of the Russian Federation I hereby order:

1. To approve a list of objects of water management of internal sea waters and the territorial sea for which the issuance of licenses for the right to use water areas shall be the competence of the Ministry of Natural Resources of the Russian Federation (in accordance with No.1 Resources of Russia (in accordance with Appendix No. 2

2. The Department of Science and Sea Work (Gloumov) and the Department of Water Supply, Management and Protection of Water Reservoirs (Nabrodov) shall provide for methodological guidance by territorial (regional) bodies of the Ministry of Natural Resources of Russia related to matters of licensing the use of water areas of internal sea waters and the territorial sea of the Russian Federation.

3. The Department of Science and Sea Work (Gloumov) shall incorporate a list to be approved as part of the Rules of Granting the Use of Water Areas of Internal Sea Waters and Territorial Sea of the Russian Federation under elaboration.

4. The territorial (regional) bodies of the Ministry of Natural Resources of Russia shall within their respective sphere of activities provide for record-keeping of all the objects of

water management of internal sea waters and the territorial sea of the Russian Federation by showing them on the maps and filing materials in the established manner.

5. The control over the implementation of the Order shall be entrusted to the First Deputy Minister N.N.Mikheyev.

List of Objects of Water Management of Federal Significance for which the Issuance of Licenses for the Right to Use Water Areas of Internal Sea Waters and Territorial Sea Shall be the Competence of the Ministry of Natural Resources of the Russian Federation

1. The intake of sea water for the needs of atomic power engineering with subsequent discharge of the used resource into sea water reservoir.

2. The use of sea water areas for the following purposes:

2.1. recreation and public health care in accordance with federal directed or international programs;

2.2. construction, reconstruction and operation of ports and port facilities of federal significance (piers, jetties, terminals, etc.);

2.3. performance of dredging to form approach canals in the water area of ports of federal significance;

2.4. construction and operation of man-made structures in the sea;

2.5. laying out of main pipelines along or below sea bottom;

2.6. prospecting, construction and exploitation of mineral deposits of the sea bottom, including hydrocarbon materials, based on the sea bottom (construction of drilling platforms and derricks, terminals, oil-loading facilities, etc.)

3. use for various needs of water areas of internal sea waters and territorial sea regarded as specially protected water reservoirs of federal or international significance.

4. The transfer of water areas of internal sea waters and territorial sea or part thereof for special usage.

In the event of using sea water reservoir for various purposes, one or several of which enjoys federal significance, a license for water management shall be issued by the Ministry of Natural Resources of the Russian Federation.

The issuance of a license shall be carried out by the Ministry of Natural Resources of the Russian Federation on the basis of a report prepared by a respective territorial (regional) body of the Ministry of Natural Resources of Russia and with the availability of approval of environment protective bodies and services of the subjects of the Federation concerned.

[*2000] Appendix No. 2 to the Russian Federation No.226 of October 14, 1998
List of Objects of Water Management for which the Issuance of Licenses for the Right to Use Water Areas of Internal Sea Waters and Territorial Sea Shall be the Competence of territorial (regional) bodies of the Ministry of Natural Resources of the Russian Federation

1. The intake and discharge of sea water for the needs of industry, power engineering (except for atomic), transport, agriculture *.

2. The discharge of effluents (including polluted) into sea water reservoirs *.
 3. The use of sea water areas and sea medicative resources for purposes of recreation, public health protection and sport, except for objects of general public significance, whose construction and management shall be effected in accordance with federal directed or intergovernmental programs.
 4. The use of sea water areas for the following purposes:
 - 4.1. upkeep, operation and maintenance of small vessels;
 - 4.2. construction and maintenance of coast-protective, coast-consolidating and other along-the-coast hydro-engineering structures, except for the port ones;
 - 4.3. execution of dredging (except for water areas of ports) and burial of extracted soils;
 - 4.4. laying cables along or below sea bottom;
 - 4.5. for the needs of management of fisheries (extraction of fish and other biological resources, preservation and reproduction of sea biological resources, etc.);
 - 4.6. undertaking various sea research operations, including geophysical on from floating means.

* The division of powers between the Basin Water Management Departments and Territorial Committees of the Ministry of Natural Resources of Russia shall be carried out in conformity with the Instructive Letter of the Ministry of Natural Resources of Russia No. NM-61/1800 of May 14, 1997.
