

**Resolution No. 244**  
**dated by July 27, 1998**  
**about measures for the implementation of the Decree of the President of RT**  
**“About Realization of the Right to Land Use”**

According to Decree of the President of the Republic of Tajikistan No. 1021 dated by June 22, 1998 “About the realization of the right to land use” and for creation of favorable conditions for the development of different forms of ownership and land farming and entrepreneurship the Government of RT decrees:

1. To approve the patterns of Certificate Ensuring the Right to Land Use and Land Passport (zemelny pai) which are attached.
2. To assign the Land Management and Land Resources Committee under the Government of the Republic to issue a Certificate and Land Passport
  - under agreement with the Government to fix the price for a Certificate Ensuring the Right to Land Use and Land Passport realization;
  - to register (reregister) Certificates for the Right to Land Use on forms of established standards since September 1, 1998;
  - in the term till August 15, 1998 to elaborate and approve the Instruction on Register, Storage and Realization of Certificates;
  - to elaborate the draft of the procedure of registration and issuing a Certificate for the right to Land Use and Land Passport till August 15, 1998 and submit for approval to the Government of RT.
3. land Committee, Ministry of Agriculture, State Property Committee jointly with local executive power structures in compliance with the Laws of RT to start restructuring of agricultural entities into dehkan (private) farms with following up establishing of Association of Dehkan Farms in compliance with the supplement.
4. To make the amendments in Resolution No. 422 from September 15, 1996 “Responsibilities of the land Committee under the Government of RT” which as follows:
  - in paragraph 2 item 4 the phrase “30 units” are to be replaced by “40 units”;
  - the structure of central body of the Land Committee is to be added by item 2:
  - “2. Department on Restructuring of Agricultural Entities” and items 2,3,4,5, and 6 are to be considered 3,4,5,6 and 7.
