BY-LAWS

Made under section 148

THE KARATU DISTRICT COUNCIL

(INSPECTION OF AGRICULTURAL PRODUCTION) (COFFEE) BY-LAWS

1. These By-laws may be cited as the Karatu District Council
(Inspection of Agricultural Produce) (Coffee) By-laws 2001.

Short title

2. These By-laws shall come into operation on the day when shall
be published in the Government Official *Gazette*. and shall apply through
out the area of Karatu District Council.

3. In these By-laws, unless the context requires otherwise:-
"Authorised Officer" means District Cooperative Officer, District Agri-
culture and Livestock Officer and District Land Officer.

"Premises" means buildings/stores/noted in contact Estates used to store
coffee before delivery to the buyers.

"Estate" means any coffee farms under contract lease in Karatu Dis-
trict.

4.-(1) There shall be made an inspection by the council in all
premisses where Agricultural produce (Coffee) is stored.

Inspection of
Premises

(2) The Council may authorise the District Cooperative Officer
District Agriculture and Livestock Officer and District Land Develop-
ment Officer to inspect all the premises and produce stored in such
premise/stores.

(3) The authorised Officer may summon any person in whose
premises coffee is stored to report to the Council on the quantity and
quality of coffee produced in his/her estate.

5. Any person who having been required to give information or
report under 4(3) wilfully misleads or attempts to mislead the Council on
any matter in connection with the collection of a rate shall be guilty of
an offence and shall be liable to imprisonment for a term not exceeding
Six months or fine of fifty thousand shillings (50,000/=) or both that fine
and imprisonment.

6. Where any person so summoned neglects or refuses to allow any authorised officer to enter the premises/stores in order to perform his/her duties shall be guilty of an offence and shall be liable on conviction to a fine not exceeding two hundred and fifty thousand shillings (TShs. 250,000/=) or to imprisonment for a term not exceeding 2 years or both that fine and imprisonment.
