**EXPLANATORY NOTE**

*(Nid yw'r nodyn hwn yn rhan o'r Gorchymyn)*

*(This note is not part of the Order)*

Mae'r Gorchymyn hwn yn diwygio Gorchymyn Iechyd Planhigion (Cymru) 2006 (O.S. 2006/1643 (Cy.158)) ("y prif Orchymyn"). Diben y diwygio hwn yw cynnwys mesurau brys i rwystro *Chalara fraxinea* T. Kowalski, gan gynnwys ei deleomorff *Hymenoscyphus pseudoalbidus*, sy'n achosi clefyd coed ynn, rhag dod i mewn a lledaenu. Yn benodol, mae'r Gorchymyn:

This Order amends the Plant Health (Wales) Order 2006 (S.I. 2006/1643 (W.158)) ("the principal Order") to include emergency measures to prevent the introduction and spread of *Chalara fraxinea* T. Kowalski including its teleomorph *Hymenoscyphus pseudoalbidus*, a cause of ash dieback. In particular, the Order:

- a) yn gwahardd glanio *Chalara fraxinea* T. Kowalski yng Nghymru neu ei ledaenu o fewn Cymru (erthygl 2(7));
- b) yn gwahardd glanio yng Nghymru neu symud o fewn Cymru blanhigion *Fraxinus* L. y bwriedir iddynt gael eu plannu a hwythau wedi eu heintio â *Chalara fraxinea* T. Kowalski (erthygl 2(8));
- c) yn gosod gofynion atodol ynglŷn â glanio yng Nghymru neu symud o fewn Cymru blanhigion *Fraxinus* L. y bwriedir iddynt gael eu plannu (erthygl 2(9) i (12)); a
- d) yn gosod gofynion atodol ynglŷn â thraddodi o Gymru i rannau eraill o'r Undeb Ewropeaidd blanhigion *Fraxinus* L. y bwriedir iddynt gael eu plannu (erthygl 2(13)).

- a) prohibits the landing in or the spread within Wales of *Chalara fraxinea* T. Kowalski (article 2(7));
- b) prohibits the landing in or the movement within Wales of plants intended for planting of *Fraxinus* L. which are infected with *Chalara fraxinea* T. Kowalski (article 2(8));
- c) imposes additional requirements on the landing in or movement within Wales of plants intended for planting of *Fraxinus* L. (article 2(9) to (12)); and
- d) imposes additional requirements on the consignment from Wales to other parts of the European Union of plants intended for planting of *Fraxinus* L. (article 2(13)).

Cyflwynodd Gorchymyn Iechyd Planhigion (Coedwigaeth) (Diwygio) 2012 (O.S. 2012/2707) fesurau brys i rwystro *Chalara fraxinea* T. Kowalski rhag dod i mewn a lledaenu. Yr awdurdod cymwys o ran y mesurau hyn yw'r Comisiynwyr Coedwigaeth. Mae'r Gorchymyn hwn yn galluogi Gweinidogion Cymru hwythau i weithredu fel awdurdod cymwys mewn perthynas â Chymru o ran mesurau i rwystro *Chalara fraxinea* T. Kowalski rhag dod i mewn a lledaenu.

Emergency measures to prevent the introduction and spread of *Chalara fraxinea* T. Kowalski were introduced by the Plant Health (Forestry) (Amendment) Order 2012 (S.I. 2012/2707). The competent authority for those measures is the Forestry Commissioners. This Order enables the Welsh Ministers also to act as competent authority in relation to Wales in respect of measures to prevent the introduction and spread of *Chalara fraxinea* T. Kowalski.

Mae'r Gorchymyn hefyd yn rhoi pwerau i Weinidogion Cymru i roi trwyddedau ar gyfer treialon neu at ddibenion gwyddonol neu ar gyfer gwaith ar ddethol amrywiaethol mewn perthynas â phlâu planhigion penodol (erthygl 9 2(5)).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar wneud Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol gwneud asesiad effaith rheoleiddiol o'r costau a'r buddiannau sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

The Order also confers powers on the Welsh Ministers to grant licences for trial or scientific purposes or for work on varietal selections in relation to certain plant pests (article 2(5)).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

The Welsh Ministers, make the following Order in exercise of the powers conferred by sections 2(1) and 3(1) of the Plant Health Act 1967(1) which are now vested in them(2):

**Title and Commencement**

1.—(1) The title of this Order is the Plant Health (Wales) (Amendment) Order 2013.

(2) This Order comes into force on 10 May 2013 and applies in relation to Wales.

Mae'r pwerau a roddir gan adrannau 2 a 3 yn cael eu rhoi i "competent authority", a ddiffinnir yn adran 1(2), o ran amddiffyn coed a phren coedwigaeth rhag ymosodiadau gan blâu, fel y Comisiynywyr Coedwigaeth ac fel arall, o ran Cymru, y Gweinidog Amaethyddiaeth, Pysgodfeydd a Bwyd.

(2) Trosglwyddwyd swyddogaethau'r Gweinidog Amaethyddiaeth, Pysgodfeydd a Bwyd o dan Ddeddf Iechyd Planhigion 1967 (p. 8), i'r graddau yr oeddent yn arferadwy o ran Cymru, i'r Ysgrifennydd Gwladol gan erthygl 2 o Orchymyn Trosglwyddo Swyddogaethau (Cymru) (Rhif 1) 1978 ac Atodlen 1 iddo (O.S. 1978/272). Trosglwyddwyd y swyddogaethau hynny oddi wrth yr Ysgrifennydd Gwladol i Gynulliad Cenedlaethol Cymru gan erthygl 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 ac Atodlen 1 iddo (O.S. 1999/672). Trosglwyddwyd swyddogaethau Cynulliad Cenedlaethol Cymru i Weinidogion Cymru o dan adran 162 o Ddeddf Llywodraeth Cymru 2006 a pharagraff 30 o Atodlen 11 iddi (p.32).

The powers conferred by sections 2 and 3 are conferred on a "competent authority", which is defined in section 1(2), as regards the protection of forest trees and timber from attack by pests, as the Forestry Commissioners and otherwise, for Wales, as the Minister of Agriculture, Fisheries and Food.

(2) The functions of the Minister of Agriculture, Fisheries and Food under the Plant Health Act 1967 (c. 8) were, so far as exercisable in relation to Wales, transferred to the Secretary of State by article 2 of, and Schedule 1 to, the Transfer of Functions (Wales) Order (No.1) Order 1978 (S.I. 1978/272). Those functions were transferred from the Secretary of State to the National Assembly for Wales by article 2 of, and Schedule 1 to, the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672). The functions of the National Assembly for Wales were transferred to the Welsh Ministers by section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32).

## Diwygio Gorchymyn Iechyd Planhigion (Cymru) 2006

2.—(1) Mae Gorchymyn Iechyd Planhigion (Cymru) 2006(1) wedi ei diwygio fel a ganlyn.

(2) Yn erthygl 2(1) (dehongli cyffredinol) yn lle'r diffiniad o "ISPM No.4", rhodder—

"ISPM No.4" means International Standard for Phytosanitary Measures No.4 of November 1995 on Requirements for the establishment of pest free areas, prepared by the Secretariat of the IPPC established by the Food and Agriculture Organisation of the United Nations(2);".

### **"Licences to carry out activities prohibited by this Order**

40.—(1) Notwithstanding any of the provisions of this Order, any plant pest or relevant material may be landed, kept, stored, sold, planted, moved or otherwise disposed of in Wales and any other thing prohibited by this Order may be done under the authority of a licence granted by the Welsh Ministers—

- (a) in exercise of any derogation permitted by Directive 2000/29/EC(3); or
  - (b) for trial or scientific purposes, or for work on varietal selections, in relation to a domestic quarantine plant pest.
- (2) A licence granted under paragraph (1)(b) must be in writing and may be granted—
- (a) subject to conditions;
  - (b) for an indefinite period or a specified period.

## Amendment of the Plant Health (Wales) Order 2006

2.—(1) The Plant Health (Wales) Order 2006(1) is amended as follows.

(2) In article 2(1) (general interpretation), for the definition of "ISPM No.4", substitute—

"ISPM No.4" means International Standard for Phytosanitary Measures No.4 of November 1995 on Requirements for the establishment of pest free areas, prepared by the Secretariat of the IPPC established by the Food and Agriculture Organisation of the United Nations(2);".

(3) In article 8(2) (exceptions from certain prohibitions and requirements)—

- (a) in sub-paragraph (a)(iii), after "potatoes" insert "or seeds of Fraxinus L."; and
- (b) in sub-paragraph (b)(ii) after "sub-paragraph (i)" insert "or plants of Fraxinus L. intended for planting".

(4) In article 22(1) (exceptions from certain prohibitions and requirements), after "small quantities of any relevant material", insert "other than plants of Fraxinus L. intended for planting".

(5) For article 40 (licences to carry out prohibited activities), substitute—

### **"Licences to carry out activities prohibited by this Order**

40.—(1) Notwithstanding any of the provisions of this Order, any plant pest or relevant material may be landed, kept, stored, sold, planted, moved or otherwise disposed of in Wales and any other thing prohibited by this Order may be done under the authority of a licence granted by the Welsh Ministers—

- (a) in exercise of any derogation permitted by Directive 2000/29/EC(3); or
  - (b) for trial or scientific purposes, or for work on varietal selections, in relation to a domestic quarantine plant pest.
- (2) A licence granted under paragraph (1)(b) must be in writing and may be granted—
- (a) subject to conditions;
  - (b) for an indefinite period or a specified period.

Kowalski (including its teleomorph *Hymenoscyphus pseudoalbidus*) in accordance with ISPM No.4".

"7b Plants of *Fraxinus* L. intended for planting which originate in a third country

Without prejudice to the requirements in item 7a, the plants shall be accompanied by a phytosanitary certificate which has been issued by the national plant protection organisation of the country from which the plants originate and which includes under the heading "Additional Declaration" an official statement that the plants have been grown throughout their life in an area which has been established and is maintained as an area free from *Chalara fraxinea* T. Kowalski (including its teleomorph *Hymenoscyphus pseudoalbidus*) in accordance with ISPM No.4".
