SUBSIDIARY LEGISLATION

FEMALE CATTLE (PROHIBITION OF SLAUGHTER AND SPAYING) REGULATIONS

To provide for the control of the slaughter or spaying of female cattle and matters connected therewith.

PROHIBITION ON SLAUGHTERING AND SPAYING FEMALE CATTLE OF OR BELOW AGE OF 7

1. The slaughter or spaying of female cattle of or below the age of 7 years is prohibited except with a licence issued in accordance with paragraph 2.

LICENCE TO SLAUGHTER OR SPAY FEMALE CATTLE OF OR BELOW AGE OF 7

2. The Principal Veterinary Officer or any other person authorised by the Minister by publication of his name in the Gazette may issue a licence to slaughter or spay cattle to which these regulations apply for any of the reasons set out in section 2(1) of the Cattle (Slaughter, Spaying and Castration) Act, Cap. 103.

APPLICATION FOR A LICENCE

3. An application for a licence under these regulations shall be in the form contained in Part 1 of the Schedule and a licence shall be in the form contained in Part 2 of the Schedule.
