

**DECISION No. 136/1999/QĐ-BNN-BVTV OF OCTOBER 5, 1999 ON CHANGING SOME NAMES OF PLANT PROTECTION DRUGS ADDITIONALLY REGISTERED IN THE LIST OF PLANT PROTECTION DRUGS PERMITTED TO BE USED IN VIETNAM, ISSUED TOGETHER WITH DECISION No. 121/1999/QĐ-BNN/BVTV OF AUGUST 25, 1999 OF THE MINISTER OF AGRICULTURE AND RURAL DEVELOPMENT**

**THE MINISTER OF AGRICULTURE AND RURAL DEVELOPMENT**

*Pursuant to the Government's Decree No. 73-CP of November 1<sup>st</sup>, 1995 defining the functions, tasks, powers and organizational structure of the Ministry of Agriculture and Rural Development;*

*Pursuant to Article 26 of the Ordinance on Plant Protection and Quarantine promulgated on December 15, 1993;*

*Pursuant to the Regulation on the Management of Plant Protection Drugs issued together with the Government's Decree No. 92-CP of November 27, 1993 guiding the implementation of the Ordinance on Plant Protection and Quarantine;*

*At the proposals of the Director of the Department for Plant Protection and the Director of the Department for Science, Technology and Product Quality and the Director of the Ministry's Office,*

**DECIDES:**

**Article 1.-** To change a number of the names of

plant protection drugs additionally registered in the list of plant protection drugs permitted to be used in Vietnam, issued together with Decision No. 121/QĐ-BNN/BVTV of August 25, 1999 of the Minister of Agriculture and Rural Development as follows:

**Article 2.-** This Decision takes effect after its signing.

The Department for Plant Protection shall have to provide detailed guidance for the safe and effective use of the above-named plant protection drugs.

**Article 3.-** The director of the Ministry's Office, the director of the Department for Plant Protection, the director of the Department for Sciences, Technology and Product Quality, heads of the units under the Ministry and domestic organizations and individuals and foreigners that manage, trade in, and/or use plant protection drugs in Vietnam shall have to implement this Decision.
