of the Department of Science, Technology and  
Product Quality;*

**DECIDES:**

**Article 1.-** To promulgate together with this  
Decision the list of minimum technical norms which  
must be announced when elaborating base standards  
for goods being animal feeds

**Article 2.-** This Decision takes effect 15 days after  
its signing.

**Article 3.-** The director of the Ministry's Office,  
the director of the Agriculture and Forestry Promotion  
Department, the director of the Department of  
Science, Technology and Product Quality, the  
directors of the provincial/municipal Agriculture and  
Rural Development Services, and organizations and  
individuals engaged in the production of and trading  
in animal feeds shall have to implement this Decision.
