The Land Survey (Amendment) Regulations, 1998

IN EXERCISE of the powers contained in section *forty* of the Land Survey Act, the following Regulations are hereby made:

APPENDIX

FOURTH SCHEDULE
(Regulation 77a)

TRIAL SURVEY

1. A trial survey for a land survey licence shall consist of two parts—
 - (a) a land title survey of an area of land not less than 50 hectares in extent, at least two boundaries of which shall coincide with and/or be reinstated from previous surveys and one or more of the boundaries of which shall be a watercourse or other natural feature or irregular road; and
 - (b) a land title survey of an urban area comprising not less than two stands, one of which shall be an irregular figure with substantial buildings encroaching on or closely adjacent to at least one of the boundaries; all old boundaries shall be redefined on the ground.
2. The surveys required under paragraph 1 shall be coordinated on the national grid system so that one of the surveys shall involve fixation of at least one control point by trigonometrical methods.
3. All field work, computations and drawings shall be undertaken by the candidate personally except in the field of survey labour where he may receive assistance.

4. Notwithstanding paragraphs 1 to 3 of this Schedule any person—

- (a) with five (5) years relevant professional experience and degree in land surveying or equivalent from an educational institution recognised by the Board or;
- (b) with eight (8) years relevant practical experience and a Higher National Diploma in land surveying or equivalent from an educational institution recognised by the Board or;
- (c) with ten (10) years relevant practical experience and a Technologist Diploma in land surveying or equivalent from an educational institution recognised by the Board.

shall be exempted from the trial survey upon satisfying the board with the requirements of the relevant sub-paragraph in paragraph 4.
